# Why UN Environment engages with the Private Sector ?

## UNEPが民間部門と協業する理由

- UN Environment recognizes that partnerships with the private sector are pivotal to achieving solutions to our global and interconnected environmental challenges.

- Our approach has evolved to reflect the call to enhance the business engagement for sustainable development and the ambitions of the 2030 Agenda for Sustainable Development and its 17 Sustainable Development Goals.

# What is the purpose of engaging with private sector ?

## 民間部門との協業の目的

- **Advancing on our Mandate and Objectives together**  
UNEPの職務と目標の両者の推進
- **Private sector partnerships can bring value to both sides**  
協業は両者に成果をもたらせる。
- For UN Environment, that means huge outreach and access to market driven development, innovation, technology and deployment of solutions.  
UNEPは、市場による開発、革新、技術及び解決策の実施へのアクセスを得る。
- For companies, it means building credibility and having a voice among policy-makers to ensure they understand the challenges and the opportunities to accelerate progress.  
企業にとっては、信頼性を増強すること、課題と進歩を加速するための機会を理解するよう政策決定者の中で発言力を持つことを意味する。

# How UN Environment partners with the Private Sector

**We deliver our mandate through seven**

**Sub-Programme (thematic areas) (主要7活動分野)**

- Climate change (気候変動)
- Resilience to Disasters and Conflicts (災害、紛争に対する対抗力)
- Healthy and Productive Ecosystems (健康な生産能力を持つ生態系)
- Environmental Governance (環境管理)
- Chemical, Waste and Air Quality (化学物質、廃棄物及び大気質)
- Resource Efficiency (資源効率)
- Environment Under Review (関心環境分野)

# How to Partner with UN Environment (UNEPとの協業の進め方)

- Partnerships are decentralized giving all Divisions and Regional Offices as well as Multilateral Environmental Agreements the opportunity to bring in fruitful partnerships that align with UN Environment's Programme of Work.  
UNEP内のすべての組織や条約事務局が関与しており、責任はそれぞれが担当している。
- The Private Sector Unit serves the coordination entity for UN Environment partnerships with the Private Sector.  
民間部門課が調整機能を担当。
- Internal Due Diligence processes must be followed before a partnership is approved and an agreement is signed.  
協業のための合意が承認され、協定が署名される前に、内部の適正評価手続きが必要。

# The UN Environment Assembly (UNEA)

## 国連環境総会

**The UN Environment Assembly is the highest authority  
on the Environment**

### **UNEAは環境分野の最上位の機関**

The UN Environment Assembly was created in June 2012, when world leaders called for UN Environment to be strengthened and upgraded during the United Nations Conference on Sustainable Development (Rio+20).

UNEAは、2012年の持続可能な開発に関する国連会議(Rio+20)で誕生した。

The Assembly embodies a new era in which the environment is at the center of the international community's focus and is given the same level of prominence as issues such as peace, poverty, health and security.

UNEAの設置は、環境を、国際社会の焦点の中央に置き、平和、貧困、健康と安全保障に並ぶものとして重要視されることとなったことを意味する。

## The UN Environment Assembly (cont.)

- The Fourth session of the Assembly (UNEA-4) was held on 11-15 March 2019 in Nairobi, Kenya. The theme was “Innovative solutions for environmental challenges and sustainable consumption and production”.

UNEA 4は、ナイロビで2019年3月11～15日に開催された。  
その中心テーマは「環境課題と持続可能な消費と生産のための革新的解決策」。

# UNEA 4 Main Political Outcomes

## 主要な政策的成果

It was an important milestone for global environmental multilateralism and achieved the following outcomes:

- Ministerial Declaration adopted (閣僚宣言)
- 23 resolutions adopted (23件の決議)
- 3 decisions adopted (3件の決定)
- Programme of Work and Budget adopted (事業計画予算の採択)
- Implementation plan “Towards a Pollution-Free Planet” (汚染のない地球に向けた実施計画の合意)
- The 6<sup>th</sup> Global Environment Outlook (GEO-6) (第6次 地球環境概況(GEO-6)を歓迎)

# Private Sector Engagement at UNEA-4

## 民間団体のUNEA-4への参画

- Private sector participated during the Fourth Session of the Assembly through various events.
- The **Sustainable Innovation Expo** is the UN Environment Assembly's premier platform for engaging the private sector and attracted more than 500 participants.  
500名以上が参加した持続可能な革新エキスポ。
- Expo included exhibition space for 46 companies to show their technology and innovation.  
46社が技術と革新に関する展示。
- It also hosted nine interactive panel discussions focusing on the theme of the Assembly.  
9件の意見交換のパネル討議会を開催。
- UN Environment welcomes innovative and sustainable solutions from the private sector that can make transformational change for generations to come.  
UNEPは、民間部門による革新的かつ持続可能な解決策を歓迎する。
